Lottery Rules

1. The Lottery shall be run for the benefit of the SCKPA.
2. The numbers drawn each Saturday will be those drawn for the National Lottery LOTTO game. Numbers drawn can be verified from <http://www.national-lottery.co.uk/player/p/home/home.do>.
3. Nobody under age 16 permitted to play.
4. It will cost as little as £1 a week (or the equivalent of £4.34 per calendar month by standing order) and the more people who join the more successful the scheme will be, so your membership will make a real difference. If you join you will stand a much greater chance of winning than through the National Lottery and the charitable part of your contribution will be going to local services that you know well and which may benefit someone you know in the future.
5. No money received, no play !
6. Each Lottery entry ticket must show the purchaser's name and contact details, as well as clearly identifying a series of 6 different numbers ranging between 1 and 49 inclusive. Chosen numbers may be in any order. Chosen Entry numbers will continue in each subsequent Game until changed by a correctly completed and submitted entry ticket.
7. Entry tickets must be received by the Promoter before the start Week of each Game. In the event an entry ticket is received late, then that entry will be null and void and, if payment has been received, then the entry cost will be used as a credit towards the next Game or reimbursed.
8. A Game will comprise numbers drawn over 6 consecutive weeks – each Game will be numbered sequentially. As soon as a winner is found, the Game ends. If a Game winner occurs earlier than week-6, then a new Game will commence immediately after the winning week – e.g. if Game-1 completes at week-4, then Game-2 will commence at week-5
9. In the event that play over 6 consecutive weeks has not identified a winner(s), then the prize fund will be carried over to the next Game. After 2 consecutive carryovers, the next Game will run to a winning conclusion.
10. In the event there is more than one winner in the winning week, then the prize fund will be divided equally between the number of winners of that Lottery Game.
11. The prize fund will comprise 50% of the total proceeds from ticket weeks sold for each Lottery Game.
12. The whole proceeds of each Lottery Game, after the deduction of amounts for expenses and prizes, will be applied to the purposes of the SCKPA.
13. 'Week' means the period from 6 a.m. on any Sunday to 11 p.m. on the following Saturday.
14. 'Winning Numbers' means the numbers used to determine the winning entries for a Draw-Based Game.
15. Dissemination of Winning Numbers Information:

(1) The results of each Draw will be made available in the form of a Lottery Result Sheet for each Game as soon as is practicable after each Draw. Results will be posted to the SCKPA website (when available) and issued by the Promoter to ticket purchasers by (i) Email where available or (ii) available on demand by post. The winner(s) of each Game will be notified directly by telephone, Email or by post.

(2) The information made available and disseminated will be:

- (a) the name or title of the Draw-Based Game;
- (b) the date of the Draw;
- (c) the Winning Numbers;
- (d) the amount payable for each correct Play;
